■ PCC Standing Committee on Automation

- Prepared the <u>PCC Authority Source Citation Task Group Final report</u>. The report is out for review by the PCC community. There was one MARBI Discussion Paper from the group that was discussed at this ALA Midwinter meeting.
- Prepared the <u>ISBD and MARC Task Force Final Report</u> (to remove redundant punctuation as displayed in an ISBD bibliographic record). The report has been approved in principle by PCC Policy Committee and will be released for review by the PCC community shortly.

■ PCC Standing Committee on Standards

- Developed the <u>BIBCO Standard Record Supplemental Requirements for Electronic</u> <u>Monographic Resources (Remote & Direct Access) Other Than Leader/06=Computer Files</u> <u>materials.</u>
- 2. Prepared a policy proposal to expand the use of the MARC 588 field to be used in all records for online resources. This was accepted and resulted in revisions of the Provider Neutral E-

- Monograph MARC Record Guide and the MARC Record Guide for Monograph Aggregator Vendors.
- 3. Developed the BIBCO Standard Record for Archival Collections
- 4. Charged three Task Groups to address the 25 issues listed in the PCC RDA Policy and Practice Decisions Task Group spreadsheet. The first will focus on the effect of RDA on Provider-Neutral Records; the second will address the effect of RDA and the BIBCO Standard Records; and the third task group will recommend PCC policy and best practices relating to multiple Authority issues.

PCC Standing Committee on Training

- 1. Kept former chair, Becky Uhl, on as a member and added three new members (terms, 2011-2014)
- 2. Formed the SCT RDA Records Task Group (Nov. 2011)
 - Charge: To collect and submit a file of complete RDA bibliographic and authority records for various types of resources in both MARC and non-MARC encoding schemes
 - Final determination: May 1, 2012
- 3. Reconstituted the Task Group to Revise the E-Serials Module (December 2011)
 - Identified a person to co-chair
 - Revised the charge
 - The revised manual will be submitted to the SCT by May 31, 2012.
- 4. As of this report (January 2012), we're finalizing the formation of the SCT RDA Training Materials Task Group
 - Charge: Working with the PCC Secretariat, collect, review, and vet existing RDA training documentation from PCC and non-PCC sources
 - Final determination: hopefully before ALA Annual
- 5. Made a recommendation to PoCo to continue involvement of the ALCTS CaMMS/PCC Committee on Education Training Materials and identified a chair and an additional member to serve as PCC representatives to that group.
