Chair's Report on CC:DA Motions and Other Actions July 13, 2012–October 25, 2012

Motions and Votes

The following is a record of motions made and votes taken between July 13 and October 25, 2012.

- **A.** CC:DA/Schiff/2012/1: The motion was to approve the proposal for the revision of RDA 19.2.1.1.1, regarding the creators of hearings. After committee discussion, Schiff re-wrote the proposal to bring RDA in-line with AACR2, according to the committee's preference. The motion passed 8-0. The proposal was sent to the JSC as 6JSC/ALA/15.
- **B.** CC:DA/MLA/2012/4: The motion was to approve the proposal for the revision of RDA 6.27.4.2, instructing catalogers not to create variant access points for the libretto of a musical work when written by the composer. The motion passed 7-0 and the proposal was sent to the JSC as 6JSC/ALA/15.
- C. CC:DA/AALL/2010/1/Rev.: Places in Certain Federations and CC:DA/CEAL/2012/1: These two proposals, dealing with the preferred names of places, were combined into one ALA proposal. The motion to approve the proposal passed 8-0 and the proposal was sent to the JSC as 6JSC/ALA/19.
- **D. Motion to revise RDA 2.2.2.2:** The motion was to approve a proposal, based on the work of the Sources of Information Task Force, for the revision of RDA 2.2.2.2. The motion passed 7-0 and the proposal was sent to the JSC as part of 6JSC/ALA/21.
- **E. CC:DA/TF/Governmental and Non-Governmental Corporate Bodies/4:** At ALA Annual in June 2012 CC:DA had approved the proposal from the Task Force on Governmental and Non-Governmental Corporate Bodies with several amendments to RDA 11.2.2 and the instructions that come under it, subject to changes based on further discussion. The committee agreed on several changes and then voted on a motion to amend the proposal. The motion passed 7-0 and the proposal was sent to the JSC as 6JSC/ALA/18.
- **F.** Motion to approve two more proposals from the Sources of Information Task Force: The motion was to approve turning two more documents from the Sources of Information Task Force into revision proposals that would amend RDA 2.1.2.2, 2.1.2.3, 2.2.2.3, and

- 2.2.2.4. The motion passed 7-0 and the proposals were sent to the JSC as part of 6JSC/ALA/21.
- **G.** 6JSC/BL/3 [Terms of rank, honour or office: Revision of RDA 9.4.1 and 9.19.1]: The motion was to authorize the JSC representative to provide ALA's responses to the proposal based on committee discussion. The motion passed 7-0.
- H. 6JSC/BL/4 [Other designation associated with the person: Revision of RDA 9.0, 9.6.1 and 9.19.1]: The motion was to authorize the JSC representative to provide ALA's responses to the proposal based on committee discussion. The motion passed 7-0.
