**Chair's Report on CC:DA Motions and Other Actions  
July-December 2013**

**Motions and Votes**

The following is a record of motions made and votes taken between July 17 and October 22, 2013.

- A. Variant title as access point:** The motion was to approve a proposal originally discussed at Annual 2013, to change various sections of RDA Chapter 6 to allow variant access points based on variant titles alone. The motion passed 7-0 and the proposal was sent to the JSC as 6JSC/ALA/24.
- B. Appendix K proposal:** The motion was to approve the final proposal from the Task Force on Appendix K, to revise and expand this appendix dedicated to relationship designators between FRBR Group 2 entities. The motion passed 7-0 and the proposal was sent to the JSC as 6JSC/ALA/25.
- C. Colour content proposal (RDA 7.17):** The motion was to approve a proposal prepared by the outgoing JSC representative to revise RDA 7.17 to correct an inconsistent treatment in RDA of color content. This proposal had also been discussed at Annual 2013 but needed further revision. The motion passed 7-0 and the proposal was sent to the JSC as 6JSC/ALA/26.
- D. Recording Relationships paper:** The motion was to approve the final discussion paper from the Task Force on Recording Relationships, also originally discussed at Annual 2013. The motion passed 7-0 and the paper as sent to the JSC as 6JSC/ALA/Discussion/3.
- E. Three Romanization tables:** CC:DA voted to approve three new Romanization Tables, for Bulgarian, Serbian, and Macedonian. The motion passed 8-0 and the tables were added to the ALA-LC Romanization Tables.
- F. 6JSC/ACOC/7, 6JSC/ACOC/8, and 6JSC/ACOC/9:** The motion was to authorize the JSC representative to provide ALA's responses to the proposals based on committee discussion. The motion passed 7-0.

- G. 6JSC/CCC/12 & 6JSC/CCC/13:** The motion was to authorize the JSC representative to provide ALA's responses to the proposals based on committee discussion. The motion passed 7-0.

- P. Rusyn/Carpatho-Rusyn Romanization Table:** CC:DA voted to approve a new Romanization Table for Rusyn/Carpatho-Rusyn. The motion passed 8-0 and the table was added to the ALA-LC Romanization Tables.
