## Meetings:

A PCC Participants' Meeting was held virtually on February 4th, 2022 in replacement of the inperson meetings (both PCC At-Large and PCC Participants). The main program was a presentation/demonstration of several PCC Wikidata pilots/projects. # **Advisory committees:**

The PCC is in the process of setting up an Identity Advisory Committee. This new advisory committee will advise the PCC on general and specific issues related to identity management and the new roles identifiers can and are playing in the information ecosphere. The committee will also assist with the integration of identity management work into the PCC community.

- Submitted a Discussion Paper to MAC for inclusion in the June agenda to support the addition of \$0 and \$1 to the 653 and 720 fields;
- Completed our latest 3-year review for PoCo;
- Possible exceptions to the Provider-Neutral Guidelines:
  - o Adding 506 fields when there is an Open Access version
    - Approved an exception, working on updating the guidelines
  - Adding fields to indicate accessibility content
    - Currently in discussion, this one is more complex and has potentially significant impact on a lot of records ;
- BABEL update (Kelley);

- Drafted suggestions for place relationships in 370 \$i and \$4. Adam Schiff gave a
  presentation on this work in the April NARDAC forum
   SCS Recent Activity (cont)
- Reviewed the final report from the PCC entities Task Group, made comments and waiting on final revisions;
- A new task group has been formed to update the guidelines for coding ISO 639-3 language codes in bibliographic records based on feedback achieved during the PCC test:
- A new task group is being formed to address best practices for the WEM Lock in the new RDA Toolkit;
- The committee reviewed the Report of the GNCRT Metadata and Cataloging Committee on the Inclusion of Manga in the LCGFT Vocabulary and expressed support. Though it is out of scope for GNCRT, the SCS Committee would also like to see an LCGFT term for Anime added:
- The committee reviewed and provided feedback to the PCC RDA Communications
   Committee on two LC-PCC PS proposals: One related to Representative Expression
   elements, and one related to Variant Titles of Works. SCS believes that the proposals
   need additional clarification or had broader implications. LC will work with the proposers
   to address the cited concerns;

# • SCT RDA Training Task Group: Monographs

Charge: Develop a training curriculum for PCC participants to catalog print and electronic book monographs using the official RDA Toolkit, LC-PCC Application Profile, LC-PCC Policy Statements, and LC-PCC Metadata Guidance Documents. While the training may include concepts and examples applicable to a variety of formats, it is expected that other groups within PCC or specialized cataloging communities will develop more in depth training for cataloging serials and other formats.

- Phase 1: Introductory Training
